#### **CHANGE OF COMPANY NAME AND LOGO**

The Board is pleased to announce that the English name of the Company has been changed from “Global Sweeteners Holdings Limited” to “Global Corn Group Limited” and the Chinese name of the Company for identification purpose only has been changed from “大成糖業控股有限公司” to “大成玉米集團有限公司”.

The Board is also pleased to announce that, with effect from the date of this announcement, the Company has adopted a new logo to reflect the change in the Company's name.

#### **CHANGE OF STOCK SHORT NAME IN ENGLISH AND CHINESE**

The stock short name for trading in the Shares on the Stock Exchange will be changed from “GLOBAL SWEET” to “GLOBAL CORN GP” in English, and from “大成糖業” to “大成玉米集團” in Chinese with effect from 9:00 a.m. on 18 June 2025. The stock code of the Company remains unchanged as “03889”.

References are made to the announcement of Global Corn Group Limited (formerly known as Global Sweeteners Holdings Limited) (the “**Company**”) dated 28 March 2025 and the circular of the Company dated 16 April 2025 (the “**Circular**”) in relation to the proposed change of the English name of the Company from “Global Sweeteners Holdings Limited” to “Global Corn Group Limited” and the adoption of the Chinese name (for identification purpose only) of “大成玉米集團有限公司” to replace the Chinese name (for identification purpose only) of “大成糖業控股有限公司” (the “**Change of Company Name**”), and the announcement of the Company dated 9 May 2025 in relation to the voting results of resolutions proposed at the Annual General Meeting. Capitalised terms used herein shall have the same meanings as those defined in the Circular unless otherwise defined herein.

## **CHANGE OF COMPANY NAME AND COMPANY LOGO**

The Board is pleased to announce that following the approval of the Change of Company Name by the Shareholders by way of a special resolution at the Annual General Meeting, the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in the Cayman Islands, certifying that the Company’s name has been changed from “Global Sweeteners Holdings Limited” to “Global Corn Group Limited” with effect from 20 May 2025.

The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies of Hong Kong on 5 June 2025 confirming that the Company has altered its name and is now registered under the English name of “Global Corn Group Limited” in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the laws of Hong Kong).

Following the Change of Company Name, the Board is pleased to announce that, with effect from the date of this announcement, the Company has adopted a new logo, as shown at the top of this announcement, to reflect the Change of Company Name (the “**Change of Company Logo**”). The existing and new logo of the Company are set out below for identification purpose:

The Change of Company Name and Change of Company Logo will not affect any of the rights of the Shareholders or the Group’s business nature, daily business operation and its financial position. All existing share certificates of the Company in issue will, after the Change of Company Name and Change of Company Logo becoming effective, continue as prima facie evidence of legal title to such Shares and will remain valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for the free exchange of the existing share certificates for new share certificates as a result of the Change of Company Name and Change of Company Logo. Any further issue of share certificates of the Company will be under the new name and new logo of the Company.
